

OFFICIAL RULES: San Francisco Holiday SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, follow the sweepstakes prompt to complete the registration process. Public libraries have free internet access. Each participant will need to do the following to be entered into the Promotion: Enter as instructed with first and last name, and email address. By completing and submitting the sweepstakes registration during the promotion period, each participant will earn one (1) sweepstakes entry. Limit of one (1) entry per participant during the promotion period.

Sponsor is the Capitol Corridor Joint Powers Authority, 300 Lakeside Dr., Oakland, CA 94612. This contest is being conducted in partnership with San Francisco Travel Association.

- 1. Eligibility:** This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor, the Bay Area Rapid Transit (BART – the Managing Agency for the Capitol Corridor Joint Powers Authority) and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. “Immediate family members” shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Drawing:** The contest is open until 5pm PST on Wednesday, November 20, 2019. On November 21, 2019, the Capitol Corridor will conduct a random drawing for one (1) winner. Potential winner will be notified using the email provided on contest page by November 21, 2019. If potential winner does not respond within 24 hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via random drawing. Providing all eligibility requirements are met, potential winners must claim prize through email.
- 3.** Except where prohibited by law, potential winner may be required to complete, sign and return an Affidavit of Eligibility/Ownership/Liability Release and Publicity Release (the “Affidavit”) prior to claiming prize. Affidavit must be returned within fourteen (14) calendar days or prize may be forfeited and an alternate winner will be selected. In the event of noncompliance with these requirements, the prize will be forfeited and an alternate winner will be selected.

The total estimated retail value of prize package is \$1,777. Odds of winning depend on the number of eligible entries received.
