CCJPA Board Members and Director Rob Padgette:

I hope you're well.

I enjoy taking the Capitol Corridor to work from Roseville to Oakland Coliseum, then from Coliseum BART to my final destination, San Leandro City Hall. I have had zero scheduling concerns until now. I was made aware that the new schedule starting October 3rd will create a morning commuting conflict. Train 527 (from Auburn) currently provides the ideal morning commute timing for passengers from Auburn, Rocklin, and Roseville. However, the new schedule implements Train 529 at a later start time from Auburn. The later start time will negatively affect Auburn, Rocklin, and Roseville commuters.

Is there an opportunity to provide a Bus Connection in these communities that will connect with Train 527, which will depart from Sacramento Valley Station, starting October 3rd? Or the better option would be to make Train 529 depart from Auburn at 0540 hours.
